Ground-breaking Ceremony at Future Site of Elders' Village

April 26, 2019 - A ground-breaking ceremony was held at the future site of the Ermineskin Elders' Village, where the Ermineskin pow-wow grounds once stood.

Along with students from MESC schools, who will be part of the construction crew of the Elders' Village, there was Jay Noel of YCHomes, Anne Wildcat, Brian Wildcat, Chief and Council, Past Chiefs, Chief and

Council from other nations, MLA rep Andy Pachenko, EPM staff, the RCMP, and dozens of attendees.

According to a Press Release from Anne Wildcat and Jay Noel on April 23, 2019: This event is to kick off an Indigenous Service Canada (ISC) pilot program called HOUSING through EDUCATION where 36 high school students in partnership with Maskwacis Education School Commission will be taught skills and trades by

hands on learning. This is a new style of learning exposing students to the construction careers while filling youth with pride in contributing to their community. Our Partner YCHomes are experts in turning 'Blueprints into Curriculums and Jobsites to Classrooms.' This is a unique funding approach being taken by Indigenous Services Canada (ISC), as they are adding a training component HOUSING through EDUCATION to the Community's local construction project, which is the building of an ELDERS VILLAGE.

They will utilize the local construction project as a back drop to 3 practical arts classes. This is an important program to Ermineskin Cree Nation Housing Department as over the next several years the number of contractors retiring far exceeds the number of youth that are registered to start their Journey to Apprenticeship.

Chief Craig Makinaw of Ermineskin Cree Nation states "This is a unique opportunity for Maskwacis students to receive high school credits towards their diploma by learning valuable life skills at the same time receiving future apprenticeship hours for potential future career in construction ",

Also the provinces NEXT Generation Careers will be signing a Memorandum of Understanding with YCHomes Inc. with Chief Makinaw to witness at this event."

The Ceremony was emceed by Anne Wildcat, the new Director of Property and Infrastructure. She acknowledged the Elders who took part in a pipe ceremony earlier that morning for the event. Also speaking at the event were Jay Noel of YCHomes, ECN Council Housing portfolio holder Jason Makinaw, MESC Executive Director Brian Wildcat, and Chief Craig Makinaw. All the speakers acknowledged the partnerships built while bringing this project forward, noting that it can only be done when all of them work together.

Jay Noel spoke about what his company was about, and what inspired its vision: "I listened to a lot of the disconnects in communities, and one of those disconnects is between high school and post-secondary, so we built something called housing through education, it's main goal is to build capacity. We've gotten 13 students in every program, we've only wanted 12 but they've always given us 13 in case one of them dropped out, and to this day we haven't had a student drop out of the program. One of the things students are going to get out of this program are life skills. Not all of them are going to become dry-wallers, not all of them are going to become framers, some of them are going to take this as life experience, of 'remember when we built that house.'

"Partnerships are what's making this work. Anne

and Bruce from the housing department have been a big help in this. Leadership's here. You have a very progressive leadership that wanted to do this, and they see the long-term goal. That long-term goal is to have the youth take over those contracting spots, where some members are going to be retiring.

"[I'd also like to thank] Careers: The Next Generation, which help us with the apprenticeship hours and the career coaching, we have Co-op, our supplier who is going above and beyond for us in supply. We have Dewalt power tools, who are actually going to come out for a day and teach our students how to use the tools, straight from the manufacturer."

Anne Wildcat also wanted to thank the Elders, the RCMP, and the housing committee, as well as the Chief and Council from other nations.

MESC Executive Director Brian Wildcat talked about MESC: "MESC is the amalgamation of all the four nations schools in Maskwacis. We run 11 schools, have 2200 students, run headstarts to grade 12 programming, and a key part of the work that MESC does is building partnerships and connections. Wahkohtowin is a major value for our school board, and for the schools in the community. And with the development of this partnership, MESC is very proud to be part of that connection and that relationship and we're hoping that a lot of good will come from this project, that it will provide a lot of opportunities in learning for the students, especially high school age students.... [it] creates a sense of hope and encourages them to continue with their learning, [and] provide[s] some skills that they can take forward as adults and into a career in the field of construction."

The housing portfolio holder on council, Jason Makinaw wanted to "thank our partners again, I know everyone's been touching on that, but it needs to be highlighted... For me, that's the biggest thing [is] bridging the gap from our youth to the Elders. [The students will] take pride in what they're doing, because they know it's their Elders that'll be taking these homes when they're complete... Also, I'd like to thank ISC, thank you guys for funding this project and bringing this project forward. Also I need to thank our past housing manager Leeann Omeasoo, she was instrumental in helping getting this off the ground, as well. I wish she was here... A big thing for me: this was just an opportunity for us to give Elders a peaceful place to live... elders lived a long time and they deserve that peace and that harmony in their life. To be able to wake up and just go about their day in a peaceful way. This was also to take some weight off our homes. We have a housing crisis, that most nations are in, so this will help some of our elders who are in multi-

generational homes. We got Elders living with their grandchildren, their kids, their great-grandchildren, so this will help take the weight off that, I'm hoping."

Chief Craig Makinaw acknowledged all the partners involved in the project, especially the housing department and the youth. He had a message for the youth and Elders: "This is a good start for you, and it's good for teamwork, too. As you work together, you get more things done, and you'll get more leadership qualities. I'd like to thank our elders for doing the ceremony this morning so that we have a good start to the day here and as we move forward."

Missing and Murdered Indigenous Women Awareness Day

May 5, 2019 — A walk was held in Maskwacis, starting at the HBMC, to raise awareness for the large number of missing and murdered Indigenous Women and Girls all across Canada and North America. Audrey Morin was in attendance and was: "Getting ready to walk in the Missing & Murdered Indigenous Women Memorial Prayer Walk in Maskwacis with [her] good friend Katherine Swampy," (left in top photo). According to a CBS interview with then Canadian Minister for the status of women in 2016, Patty Hadju, the government has no exact number for MMIWG, with estimates ranging from 1200 to 4000.

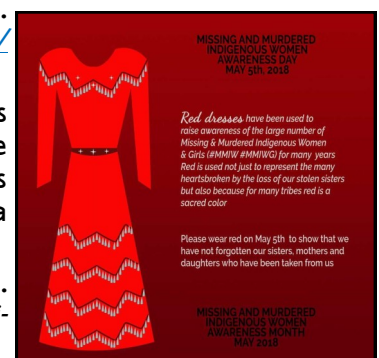

A national, toll-free support call line is available to provide support for anyone who requires assistance. This line is available free of charge, 24 hours a day, 7 days a week.

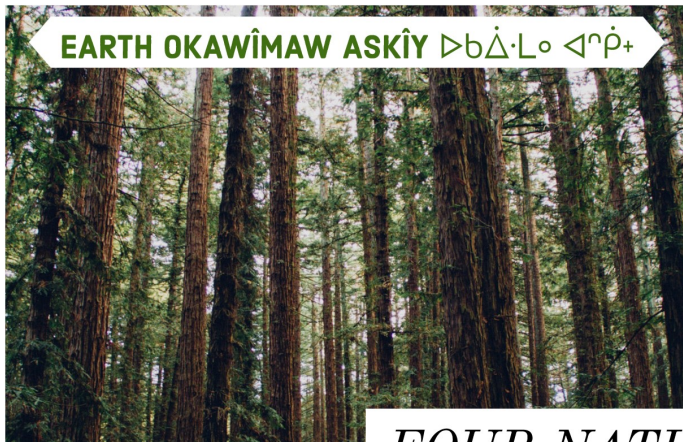

TREATY NO. 6 TERRITORY and EDMONTON, Nov. 14, 2018 /CNW/ - At an Alberta Assembly of Treaty Chiefs meeting many Treaty Nations have stated their opposition to Canada's proposed Indigenous Rights and Recognition Framework Legislation. We are Treaty Tribes, Nations and Peoples of Treaty No. 6 (1876 and adhesions thereto), Treaty No. 8 and Tsuu T'ina, Treaty No. 7. Several Treaty Chiefs have sent letters to Prime Minister Justin Trudeau to ensure that the positions of Treaty Nations is on record regarding rejection of Canada's Proposed Indigenous Rights Recognition and Implementation Framework. The letters are in response to Minister Carolyn Bennett's public message, "No stopping the framework, says Minister Bennett, but she's listening (October 29, 2018)." "The First Nations have made it known publicly and in writing that Canada's aggressive agenda to expedite plans to create legislation designed to deny our rights to lands and resources have been done all without our Free Prior and Informed Consent (FPIC). This does not bring Honour to the Crown," Chief Craig Makinaw.

"Our sacred treaty matters were not addressed – instead the Minister in July of 2018 sent out a form letter that completely mischaracterized the process and did not include one word on the treaty issues raised in our letter. Onion Lake was not the only Nation to send a letter against the process. Canada has chosen to ignore those letters resorting to fabrications," stated Okimaw Henry Lewis.

There was an expedited engagement period for the Framework process, and the results contained in the roll-up documents were selective in nature, supporting only Canada's pre-determined positions and goals and were dispensed only at federally pre-selected and managed meetings, and not released to our Nations.

Chief Kurt Burnstick has stated: "As Treaty Peoples, Canada always must bring the honour of the Crown into dealings with our Nations. The present process is full of sharp dealings that bring no honour to either the Crown or the state of Canada."

"The Framework is in direct conflict with our Treaty, inherent rights and title. The process does not recognize nor respect our jurisdiction," stated Chief Tony Alexis.

"It is clear for our First Nations that continuing with this process will result in a major set-back for the renewal of the relationship between Canada and Treaty First Nations," stated Chief Billy Morin.

"In light of the deteriorating situation in Canada, the Treaty Peoples have tried many ways to open a dialogue with Canada. We have written letters and provided materials to Canada without any formal response. For the sake of our Peoples' and our children's children, we must collectively find a path to advance and implement the Treaty made with the British Crown," stated Chief Eddy Makokis. “Since the 2015 Federal Election Justin Trudeau has coopted terminology like “nation-to-nation”, “reconciliation”, “decolonization” “self-determination” and “Inherent & Treaty Rights”. This has confused many of our people and hidden the true intent of the Trudeau government’s Indigenous Policy and Rights Agenda.”

“In order to re-colonize First Nations into assimilated “Indigenous-Canadians”, the Trudeau government has unilaterally imposed 10 Principles on Indigenous Relationships and started to dissolve the Department of Indian Affairs. Trudeau has imposed two new federal departments over First Nations to implement a new law and policy “Framework”.”

“This federal legislation must be stopped and a new process started that is based upon our original instructions from the Creator; our pre-existing sovereignty; our Aboriginal Title; our historic Treaties; our internationally recognized right of self-determination; the restoration of our stolen lands, territories & resources, or restitution for lands, territories and resources not returned!”

“Trudeau’s “Rights Recognition Framework” is a Threat to Our Survival... The “Framework” is a collection of federally imposed law and policy designed to terminate our pre-existing sovereignty and collec-

tive rights as Indigenous Nations and get us to surrender to Crown sovereignty as ethnic minorities, also known as, “Indigenous Canadians” NOT as Indigenous Nations.”

A national Day of Action has been called for June 2, 2019, with regional/community actions suggested for May 13-17, 2019 (teach-in’s, information sessions, local events, etc.).

Defenders of the Land is a network of Indigenous communities and activists in land struggle across Canada, including Elders and youth, women and men, dedicated to building a fundamental movement for Indigenous rights, and was founded at a historic meeting in Winnipeg from November 12-14, 2008. *Idle No More* was founded by four women in November 2012 in response to several bills passed in Canada that undermine Indigenous rights and environmental protection. *The Truth Campaign* is a core team of people who worked on Russ Diabo’s 2018 campaign for the position of AFN National Chief and who are now working to get Crown governments and Canadian society to address “Truth Before Reconciliation” because the Truth and Reconciliation Commission and its Calls to Action are not sufficient to address the colonization that First Nations have historically experienced and which continues today particularly under the colonial policies and legislation passed under the Constitution Act 1867.)

WHAT IS THE "FRAMEWORK"?

- The "Framework" is a collection of federally imposed law and policy to be passed by Parliament.
- This is designed to terminate our existing sovereignty, self-determination, collective Aboriginal Title & Rights and Treaty Rights as Indigenous Nations.
- The "Framework"—if passed—will form the basis for ALL RELATIONS between the federal government and Indigenous Peoples (First Nations, Metis, Inuit) including pre-1975 Treaties.
- The Trudeau government is falsely calling this "Framework" Indigenous "self-government" & "self-determination".
- The Prime Minister has said these "Indigenous Governments" are a lower order of government than municipalities (City Council) as the "4th level" of government in Canada. A "new" order of government.

IMPACTS OF FRAMEWORK

1. Will contain federal definitions of Inherent Right to Self-Government, Aboriginal Title and Rights, & Treaty Rights.
2. Federal and Provincial/Territorial powers and jurisdictions will continue to dominate over First Nations. Provincial governments will have a veto over any agreements affecting their jurisdiction.
3. The federal legislation will determine and enforce a "list of powers" for "Indigenous Governments", which can only be amended by the federal government.
4. New funding arrangements will be enforced and the Indian Band's tax exemption will be removed and First Nations will be forced to create their own source revenue.
5. Existing Organizations and/or new Institutions will be created to advocate for Indigenous rights, such as AFN and local organizations to implement and enforce this Framework.

TIME FOR ACTION!

The "Framework"—if passed—will affect generations of our people and we haven't had any say in the process or their plan!

This "Framework" breaks our original relationship with our lands, territories and resources as Indigenous Nations.

THE TIME IS NOW for Indigenous First Nation Peoples—as the legitimate rights holders—to get organized and exercise our own decision-making powers with Free, Prior Informed Consent.

The legitimate rights holders, **THE PEOPLE** will make decisions through our governance systems - families/clans, communities and as nations.

COLLECTIVELY, we will be directing leadership as international self-determining peoples on our issues!

THE 60S SCOOP CLASS ACTION: SUPPORTING SURVIVORS WITH THEIR CLAIM FORMS

Excerpt from the "SUPPORTING SURVIVORS OF THE 60S SCOOP: UNDERSTANDING THE CLASS ACTION CLAIM FORMS" Powerpoint by Patricia Barkaskas and Caity Goerke

Getting Started:

The Settlement Agreement

"Survivors of the Sixties Scoop sued the Federal Government of Canada ("Canada"). The courts have now approved a settlement between the survivors and Canada that provides compensation for loss of cultural identity for certain survivors of the Sixties Scoop."

Collectiva

A website that takes the role of the class action administrator.

Eligibility

▪ Dates

–Were you taken into care or adopted out between 1951 and 1991?

▪ Time in care

–Were you adopted? Were you made a permanent ward?

▪ Cultural loss

–Were your foster or adoptive parents non-Indigenous?

▪ Registration

–Do you have Indian Status?

–Are you eligible for Indian Status?

–Are you registered with an Inuit Land Claim?

–Are you eligible to be registered with an Inuit Land Claim?

▪ Exclusion of Metis survivors

▪ Deceased claimants

–Claimant has to have been alive on February 20, 2009

–Claim can be submitted by the Estate Executor for that claimant.

▪ Claimants with disabilities

–Claim can be submitted by the Estate Executor for that claimant.

▪ Reconsideration and Exceptions

"The claims process is intended to be expeditious, cost effective, userfriendly and to minimize the burden on the applicant. The Adminis-

trator and the Reconsideration Officer shall, in the absence of reasonable grounds to the contrary, assume the applicant to be acting honestly and in good faith. The Administrator and the Reconsideration Officer are instructed to draw all reasonable and favourable inferences that can be drawn with respect to the application, as well as resolving any doubt as to whether a claim has been established in favour of the applicant."

"The Parties agree that they are not currently able to precisely contemplate or describe exhaustively all of the criteria for qualification as an Eligible Class Member. The Parties desire to establish a procedure to avoid injustice and ensure that Individual Payments are paid to Eligible Class Members in accordance with the underlying principle of this Agreement; specifically, compensation for long term placement with non-Indigenous families resulting in cultural loss."

Compensation

Compensation is specifically for cultural loss

▪ The class action is not meant to compensate for abuse and it does not prevent class members from pursuing individual claims outside of the class action process.

▪ Compensation amount:

–If fewer than 20,000 eligible claimants = \$50,000

–If between 20,000 and 30,000 eligible claimants = \$25,000

–If more than 30,000 eligible claimants = \$750 million/number of claimants
